They can see a path between what is and what could be, and can articulate a plan to get there.

## 08 Leaders Take Initiative.

They see what needs to be done and act.

## 10 Leaders Are Resilient.

They persevere despite knowing that positive change can be difficult, take a long time, and provoke resistance.



The Executive Leadership Development Program (ELDP) was commissioned by the United States Department of the Interior's Office of Insular Affairs to provide emerging Pacific-island leaders with the knowledge and skills they'll need to excel personally and professionally.

The ELDP is managed and administered by the Graduate School USA's Pacific & Virgin Islands Training Initiatives. Program participants from throughout the US-affiliated insular areas meet for four, one-week periods over the course of a calendar year. The inaugural ELDP class completed the program in 2009, and there are now 155 alumni and current program participants from all of the U.S.-affiliated insular areas (including the U.S. Virgin Islands.) ELDP alumni represent virtually every government agency, serving the insular governments as elected representatives, ambassadors, judges, cabinet members, directors, and dedicated public servants.
