## 1A. 14th MCES Joint Communiqué

The Commonwealth of the Northern Mariana Islands, the Territory of Guam, the Federated States of Micronesia and its States, Yap, Kosrae, Pohnpei and Chuuk, the Republic of the Marshall Islands and the Republic of Palau

#### Introduction

The Chief Executives of the Governments of the Commonwealth of the Northern Marianas, the Territory of Guam, the Federated States of Micronesia and its states, Yap, Kosrae, Pohnpei and Chuuk, the Republic of the Marshall Islands and the Republic of Palau held their Fourteenth Micronesian Chief Executives' Summit (MCES) in Koror, Republic of Palau, on December 15-17, 2010. This Summit resulted in the adoption of regional programs of action in the focal areas of solid waste management, conservation through the Micronesia Challenge and related environmental programs, renewable energy, invasive species, health, transportation, workforce investment, communications and tourism. The Summit also moved forward on efforts to develop the Micronesia Center for a Sustainable Future (MCSF), making use of an inception grant from the Department of Interior. The Summit also resulted in actions in miscellaneous areas of concern to the sub-region.

The Summit reaffirmed the commitment of each of the participants, on behalf of their people and their governments, to continue to establish closer ties, expand future discussions and agree on beneficial initiatives for the benefit of the entire Micronesian Region.

His Excellency, the Honorable Johnson Toribiong of Palau, as Chairman, expressed his appreciation to the Chief Executives and their jurisdictional representatives for their attendance and active participation in the Fourteenth Micronesian Chief Executives' Summit. He also recognized the attendance of many of the region's international diplomats and U.S. representatives, including the Assistant Secretary for the Department of the Interior, Anthony Babauta. Special thanks were given to Ambassador Maggie Taiching Tien, Republic of China (Taiwan), for her country's financial assistance in hosting the 14th MCES.

His Excellency, the Honorable Emanuel Mori, as the Secretary General of the MCSF, also expressed his appreciation to each Chief Executive, as well as the Designated Representatives and delegations of each Jurisdiction.

Following the opening ceremonies of the Summit, which included statements by each of the Chief Executives, reports and recommendations from regional committees were given, along with presentations on a number of issues of interest in the region, as reflected in this 14th Communiqué.

## Micronesia Regional Invasive Species Council (RISC)

The RISC Committee reported that cooperation through RISC has yielded significant progress in the advancement of invasive species awareness, prevention, and control in Micronesia, cooperation which is essential for both regional and local success.

Regarding recent activities, the Committee reported that the RISC calendar for 2011, an important awareness-raising tool, will be completed in December and distributed in early 2011. The calendar was funded by the Secretariat of the Pacific Community (SPC), and coordinated by the RISC Secretary. In addition, RISC members have supported the development of the Micronesia Biosecurity Plan (MBP) by providing local expertise to federal scientists who are completing risk and pathway analysis reports that form the basis for the MBP. The scientific reports are due on March 2011 and RISC will coordinate an informal review of these reports by local experts in each jurisdiction. RISC participation in the development process will help ensure that the final MBP will accurately portray priorities and needs within Micronesia for restricting the introduction and spread of invasive species throughout Micronesia.

To plan for the eventual implementation of the MBP, a proposal to develop a Strategic Implementation Plan was submitted to the Department of Defense (DOD) for funding.

The Chief Executives recognized the accomplishments of the Committee and reaffirmed their commitment to:

- Provide a permanent and full-time Invasive Species Coordinator for each jurisdiction;
- Identify, in writing to the Chair of RISC, two representatives to RISC from each state and national jurisdiction;
- Send RISC representatives to two workshop-style meetings per year, in addition to the Summits, to collaborate on invasive species issues and priority actions;
- Provide a minimum of \$2,500 from each jurisdiction to fund RISC's priority projects, as soon as the RISC bank account has been opened;
- Continue to instruct invasive species coordinators and other appropriate staff to participate
  actively in the development of the Micronesia Biosecurity Plan (MBP); and
- Support MCSF assistance in funding the strategic action plan and emergency response training for RISC members in April 2011.

In addition, in support of the efforts of the Committee, the Chief Executives signed a letter requesting the SPC to fill the position of Plant Protection Specialist for Micronesia in 2011.

## Regional Workforce Development Council (RWDC)

The RWDC and Pacific Workforce Investment Workgroup (PWIW) reported on their efforts to continue to nurture and support the regional economic strategies guided by the Workforce Innovation Regional Economic Development (WIRED) principles and Strategic Doing! (Micronesia Works...Shaping Regional Talent Development Systems). This approach continues to deliver and update the provisions of the

RWDC 5-year strategic plan. The RWDC and PWIW held a technical meeting in Koror, Republic of Palau on December 13-14, 2010 with participating delegates and observers, including the Center for Micronesian Empowerment (CME). Area reports highlighted program updates and workforce investment/development strategic opportunities and discussions included council updates and specific RWDC recommendations presented for endorsement.

The Chief Executives took the following actions in support of the RWDC recommendations:

- Endorsed a follow-up letter to the Secretary of the U.S. Department of Labor regarding the status of the MCES Regional Job Corps Initiative;
- Endorsed the importance of extending training opportunities through the Procurement
  Technical Assistance Center (PTAC) to expand into the region -- This includes leveraging the
  existing PTAC structures that exist in Guam, and including related programming support
  strategies such as the Small Business Development Center through the Small Business
  Administration (SBA);
- Supported the STEAM initiative that provides for the positioning of the K-12 and post-secondary educational delivery systems to support Science, Technology, Engineering, Agriculture/Aquaculture and Math talent development skill sets;
- Endorsed the extension of invitations by the RWDC to all regional Chambers of Commerce to support the E-commerce regional initiative and to include active partnering of the Small Business Administration and U.S. Department of Agriculture programs and access to program resources;
- As it relates to the Guam Military Buildup, endorsed the expansion of the National Defense
  Authorization Act's area of solicitation to include specific recruitment strategies that allow
  priority to U.S. and Micronesian workers in support of the MCES Micronesia Works interests;
  and
- Recognized the positive contributions to the MCES RWDC Strategic plan made by certain collaborative entities (Center for Micronesian Empowerment and the Secretariat of the Pacific Community) and endorsed their resolutions specific to the provisions defined in the 5-year strategic plan goal areas and objectives.

## Micronesia Challenge

The Micronesia Challenge (MC) Steering Committee reported to the Chief Executives that since the 13th Micronesian Chief Executive Summit, progress has been made on implementation of the Micronesia Challenge. The Steering Committee provided an update on the election of new officers: CNMI Focal Point Fran Castro as Chair, RMI Focal Point Yumi Crisostomo as Vice-chair, and Guam Focal Point Vangie Lujan as Secretary. The Committee thanked outgoing Chair Marion Henry, Focal Point from the FSM, for his leadership over the past 3 years. Palau will host the MC Regional Office and is currently identifying an appropriate space.

The MC Committee reported that they have drafted a Five-Year Strategic Action Plan for the Steering Committee and Regional Office, articulating their vision, mission, goals and objectives, and clarifying roles and responsibilities, which is to be finalized by the end of January 2011. The Committee has agreed to reduce annual dues to \$10,000 per jurisdiction to be contributed at the beginning of each fiscal year. Charlene Mersai resigned as Regional Coordinator in October to pursue other interests and the Committee thanked her for hard work for the past two years. The Regional Coordinator position terms of reference will be advertised once finalized. The MC Committee also reported on conservation measures, fundraising and sustainable finance, and communications. For conservation measures, the MC regional database, coordinated by the Office of the Palau Automated Land and Resource Information System (PALARIS), is currently being piloted. A workshop on standardizing marine data collection and analysis with participants throughout Micronesia was held in Saipan, CNMI in November 2010, with support from NOAA.

Regarding fundraising, Governor Fitial presented an "ask" for support for all jurisdictions in the Challenge at the last U.S. Coral Reef Task Force Meeting in Guam, Saipan, and Pohnpei in September 2010. NOAA is currently working to secure approximately \$1.5-2M annually in their budgets as a result of his request. Palau's Green Fee has raised a total of nearly \$1.3 million since the inception of the program in November 2009 and the Protected Areas Network Board is being chartered.

In addition, the MC Regional Business Plan draft is under review by the MC Focal Points and appropriate agencies in each jurisdiction and will be finalized by the end of December. The plan will then be presented to the Chief Executives for review and endorsement.

As to Communications, the Committee reported that Guam and CNMI have initiated the MC Marketing, Outreach & Sustainable Support Plan, including the redesign of the website (www.micronesiachallenge.org), featuring interactive newsletters to be updated quarterly, and a series with episodes focusing on different aspects of the MC. A Sponsorship Drive will be launched in January 2011.

The Committee also provided an update on the MC Young Champions program which includes new interns for the CNMI (2), Guam (1), the RMI (1), the FSM (1), and Palau (2).

The MC Committee then briefed leaders on the next steps that need to be taken to move the MC forward, including:

- Implementation of recommendations for sustainable financing at the jurisdictional level identified in the MC Regional Business Plan;
- Securing additional funding for a regional terrestrial measures workshop (currently \$16,000 has been secured from The Nature Conservancy); and
- Collaboration with other environmental initiatives (e.g., invasive species, solid waste, energy, MCSF, etc.)
- Based on the recommendations of the MC Steering Committee, the Chief Executives supported the following activities:

- Engagement in bi-lateral and multi-lateral high level discussions to leverage support for the MC;
- Continued support for policies for on-the-ground conservation and mainstreaming of environmental efforts in development plans; and
- Continued promotion of the MC at the regional and international levels to sustain interest in the initiative and help fundraising efforts for both the endowment and ongoing regional work, especially at the following meetings:
- The U.S. Coral Reef Task Force Meeting in Washington, DC in February 2011;
- The Asia-Pacific Economic Cooperation Summit in Hawaii in November 2011;
- The 17th Conference of the Parties to the U.N. Framework Convention on Climate Change (UNFCCC COP16) in South Africa in November –December 2011.

## **Regional Energy Committee**

The Energy Committee reported that the Green Energy Micronesia initiative continues to serve as the platform for regional response to the issue of climate change mitigation, and in that context, jurisdictions continue active on-the-ground Energy Efficiency (EE) and Renewable Energy RE projects and research to meet the 20-30-20 Target.

The Committee also reported on a number of regional information sharing activities, including:

- The First Polynesia/Micronesia Regional Symposium on Energy Security held in Saipan (Oct.19-21, 2010) and hosted by the Energy Development in Island Nations (EDIN) partnership, where Palau reviewed its Energy Efficiency Subsidy Program and the Renewable Energy Financing Program;
- The Center for Island Sustainability Conference to be held in 2011 to launch the Guam MCSF Energy Policy Network; and
- National initiatives to develop country specific energy sector websites for regional and international sharing and accessibility energy data, statistics and projects.

In addition, the Committee noted current and potential funding sources critical to moving forward with national and regional energy planning and implementation, including:

- The European Union EDF10 North REP funds and installation of country based energy specialists for each of the FAS countries; and
- U.S Government ARRA funds for RE and EE to each of the U.S. Territories.

The goal of the Committee is to assess how each of these funds can be accessed to support or co-fund regional energy initiatives such as the Micronesia Energy Association (MEA).

The Committee also reported on the Framework for Action on Energy Security in the Pacific, which was finalized and adopted by Energy Representatives of each jurisdiction. The Committee acknowledged the primacy of National Energy Policies and Plans as the principal mechanism for achieving energy security in the Pacific.

Finally, the Committee reported that the success of the Micronesia Energy Association requires:

- Continued engagement with the SPC, the Pacific Regional leader on energy issues;
- Formulation of a regional energy 'Road Map';
- Assessment of the capacities needed in various jurisdictions, including the MEA;
- Assessment of available and potential financing options and the development of a sustainable financing plan; and
- A clearly defined partnership-framework with all relevant development partners and stakeholders of the energy sector in a coordinated whole-of-sector approach to energy issues at the regional level.

The Chief Executives noted the recommendations of the Committee and directed the Committee to continue the tasks necessary to implement their recommendations.

## Solid Waste Management - Pacific Islands Regional Recycling Initiative Council (PIRRIC)

After being provided an update regarding the various projects and conference participations of PIRRIC members, the Chief Executives supported the following recommended PIRRIC Committee project opportunities and activities in the region:

- The updating and funding of an internet portal that will allow the uploading of and access to waste management related documents for the region;
- The participation by PIRRIC in a proposed Pacific Islands Regional Recycling workshop hosted by the U.S. EPA;
- The participation by PIRRIC at Guam's Center for Island Sustainability Conference in partnership with the University of Guam;
- Palau's hosting of the Pacific Islands Environment Conference in September 2011 in partnership with US EPA, Region IX; and
- The proposed participation by PIRRIC in preparatory meetings for "Rio + 20" to demonstrate regional cooperation in addressing common issues regarding solid waste management and other related issues.

## **Regional Tourism Committee Report**

The Regional Tourism Committee reported that the PATA Micronesia Chapter recently held its 3rd Tri-Annual Meeting in Guam, December 1-3, with its next Tri-Annual Meeting scheduled for Kosrae in April 2011. It is at these meetings that PATA Micronesia Chapter continues to pursue its efforts in regard to regional marketing and promotional efforts, providing the following updates.

- Update #1 Regional Branding Initiative: The following have been completed:
- Development of a Request for Proposal (RFP);

- An RFP has been announced globally;
- A selection committee has been established with members from each jurisdiction; and
- RFP proposals have been received and reviewed by the selection committee for their recommendation to the PATA Micronesia Chapter Chairman.

#### The following action steps are pending:

- Identify funding sources (i.e. U.S. Federal Grants, PATA Micronesia Chapter, Airlines, NTOs/STOs, or other private funding sources); and
- Award of contract to the selected bidder.
- Update #2 Marketing Outreach to the Military Market: With the support of the Micronesian Chief Executives, the PATA Micronesia Chapter has been successful with the following marketing and promotional initiatives for the 3rd Quarter of 2010:
- The PATA Micronesia Chapter booth at the GMIF in Guam;
- On-going creation of package deals for each island destination;
- The "Wahoo Night" Exhibition by Micronesian Divers Association in October 2010 in Guam attended by CNMI, Guam, Palau, Kosrae, Chuuk and Yap;
- The Navy MWR Travel Fair in October 2011 in Guam with exhibitions by CNMI, Palau, Kosrae, Chuuk, Yap and the Marshall Islands;
- The Andersen Air Force Base Travel Fair in October 2011 in Guam, with exhibitions by the CNMI, Palau, Kosrae, Chuuk, Yap and the Marshall Islands; and
- On-going Print Advertisements in R&R Pacific Magazine by CNMI and Palau.
- Update #3 Luxury Cruise Market: Recognizing the Luxury Cruise business as a highly potential niche market for the region, PATA Micronesia Chapter has initiated marketing strategies, to include:
- A Micronesia presentation at the Miami Cruise Conference in March 2011 in Miami, Florida;
- Micronesia Cruise Association (MCA) definition and membership;
- Cruise Ship Industry Goals and Strategies, and MCA Five-Year Objectives;
- Cruise Ship Activity;
- Developing A Port Profile by each jurisdiction; and
- Creation of a Cruise Ship Task Force.

The Chief Executives supported the recommendations of the Tourism Committee and directed the Committee as follows:

- Encourage government partnership in identifying sites for nomination as World Heritage sites in recognition of the importance of preservation and sustainable development;
- Solicit proposals from qualified companies to do a study of the economic impact of the tourism industry in the Micronesia region;

- Provide support to Congresswoman Madeleine Bordallo's Bill (HR 6015) to require the Director
  of the Bureau of Economic Analysis of the U.S. Department of Commerce to publish certain
  economic data regarding territories, including the Freely Associated States, and
- Seek the support of their jurisdictions to collectively and respectively finance the active participation in Trade/Travel Shows/Exhibitions/Seminars, etc. in key markets.

## **Regional Health Committee (HC)**

The Regional Health Committee gave a status report on the crisis of non-communicable diseases in the region and on recent outcomes resulting from PIHOA Resolution 48-01, "Declaring a Regional State of Health Emergency due to the Epidemic of Non-Communicable Diseases in USAPI". This Resolution was passed by the Pacific Island Health Officers Association in May of 2010 and endorsed by the 13th MCES in Saipan, CNMI, in June 2010. Since that time, other key organizations have endorsed the resolution, including:

- The 10th Micronesian President's Summit;
- The 5th Micronesian Traditional Leaders Conference; and
- The 51st meeting of the Association of Pacific Island Legislatures, which identified the NCD crisis as the theme for its next meeting.

The Regional Health Committee emphasized the importance of continuing to align international, regional and sub-regional bodies behind comparable resolutions, declarations and commitments that address the NCD crisis. Such harmonization will help leverage and coordinate resources and significantly strengthen mandates locally for more effective community-based efforts related to NCD prevention and control.

The Regional Health Committee reminded MCES participants that the world's fattest countries and territories are in the Pacific. Among Pacific entities, the USAPI rank the highest in obesity and some indicators for NCDs. For all MCES countries, NCDs are the leading causes of death, hospital admissions, off-island medical referrals, hemodialysis, disability, and loss of productivity. Rates of childhood obesity are rising in the USAPI, and if left unchecked, NCDs will significantly impede the economic and social development of MCES countries. Non-communicable diseases—including diabetes, hypertension, stroke, heart disease, and gout—are lifestyle-related diseases caused significantly by obesity, poor nutrition, tobacco use, alcohol abuse and lack of physical activity—all avoidable conditions with a coordinated, cross-sectoral approach to prevention.

The Health Committee emphasized the importance of executive leadership in:

- Mobilizing resources through policy prioritization;
- Changing the model of health care from the bio-medical disease model to a more integrated environmental approach (the wellness model);
- Creating a better balance between the care and treatment of disease and the prevention of disease and promotion of health, including the balance of resources devoted to each;

- Involving the "whole of society" by empowering people, communities and the workforce to pursue, possess and apply the knowledge of NCD prevention in all sectors; and
- Using NCDs to re-frame health systems priorities, e.g. strategic planning, health human resources, laboratory strengthening, health data systems, quality assurance, and connectivity, thereby providing greater focus and urgency to the development of sustainable and responsive health systems in the USAPI.

The Chief Executives supported the reported efforts of Committee and recommended the following:

- Continue strengthening the MCES agenda for non-communicable disease: explore strategies for encouraging NCD-related priorities among all sectors, including health, trade, education, and finance and for integrating NCDs into the overall strategic priorities of the MCES Secretariat, the Micronesian Center for a Sustainable Future;
- Continue to increase knowledge and awareness of the NCD crisis in the USAPI among international, regional and sub-regional bodies;
- Support a cross-sectoral economic analysis of the current and projected impact of NCDs in the USAPI and request technical assistance from agencies for this; and
- Strengthen MCES advocacy for U.S. Medicaid eligibility for citizens of the Freely-Associated
  States residing in U.S. States and Territories, as an important step in NCD prevention and control
  for these individuals -- To this end, invite the newly-elected Governor of the State of Hawaii, the
  Honorable Neil Abercrombie, to the 15th MCES to discuss and coordinate strategies for
  achieving Medicaid eligibility for Compact Migrants.

## **Transportation Committee**

The Transportation Committee continues to consider security issues at the airports and seaports of member states to meet the minimum International Maritime Organization and International Civil Aviation Organization requirements, as well as those requirements of the U.S. Transportation Security Administration and the U.S. Coast Guard. These are on-going responsibilities taking into account modern sea and air transportation security issues. The Committee also reported on the need to expand air and shipping services to all Micronesia islands. The Committee is currently reviewing the outstanding proposal to extend the eligibility of Micronesia airports' for AIP grants.

The Committee also reported on work opportunities for its citizens as Deck Officers on ships that serve the MCES states under Micronesian Shipping Commission licenses to provide Micronesian citizens the necessary qualifications for higher levels of licenses leading to marine pilot qualifications.

Further, the committee noted that new changes to the STCW Convention (International Convention on Standards of Training, Certification and Watchkeeping for Seafarers) were approved in Manila in June of this year and will become effective in 2012. The changes will allow licenses issued by approved "white list" countries to be accepted internationally. The Committee also reported that the Defense Mapping Agency for U.S. Department of the Navy may no longer print nautical charts for the small islands.

The Chief Executives supported the work of the Committee and directed the Committee to:

- Move forward with the extension of Micronesia airport grant eligibility in 2012 and beyond;
- Continue to work to gain service of Micronesian citizens on ships under Micronesian Shipping Commission Licenses; and
- Further investigate the issue of nautical chart printing and, if appropriate, to request the U.S.
   Department of the Navy to continue this service, as it is critical to the maritime safety of the FAS.

#### **Communications Committee**

The Communications Committee reported that, after significant discussion, it has become apparent that the telecommunications issues faced by the Freely Associated States vary significantly from those faced by Guam and the CNMI due to the very different levels of technology currently in place and also due to the levels of privatization that have been achieved in the latter two jurisdictions.

The Committee therefore recommended that discussions regarding communications issues between the Freely Associated States be transferred to the forum of the Micronesian Presidents' Summit, that the Communications Committee at the MCES be disbanded, and that communications officials support other committees where needed in the future.

The Chief Executives recognized the great significance of telecommunications to development in the region, but also took the Committee's concerns into account and directed that Communications Committee be eliminated and that communications issues be dealt with on an ad hoc basis in the future.

#### Micronesia Center for a Sustainable Future

The Secretary General (SG) reported that the MCSF inception award was formally presented by Assistant Secretary of the Department of the Interior for Insular Affairs, the Honorable Anthony M. Babauta. The award amount of \$494,000 exceeded the requested amount that was submitted by the SG on behalf of his MCSF colleagues following the 12th MCES Summit. The effective period of the contract, which is being implemented by the Graduate School, is through June 13, 2011.

In direct response to the decision adopted in the Joint Communiqué of the 13th Micronesian Chief Executives Summit (MCES) in which, "the Chief Executives agreed to send (Designated) Representatives to an inception meeting to develop organizational structures, initial program delivery and (further) development of a regional strategic framework," a meeting was hosted by Palau on October 5-6, 2010. The "Proceedings of the First Planning Meeting of Designated Representatives" were delivered to the Chief Executives and shared with interested parties. This document provides a thorough summary of the outcomes of the meeting and the recommendations made to the Chief Executives, to establish workable procedures and protocols for the operations of the MCSF during the period of the DOI/OIA-funded inception award and thereafter. The document is also available on the website for the 14th MCES at www.mcespalau.info.

To address concerns raised by the Chief Executives at the 13th MCES, the Designated Representatives proposed a series of procedures and protocols designed to ensure jurisdiction-wide oversight of the MCSF inception award implementation and clear decision-making authority of the Chief Executives both directly and indirectly through their duly Designated Representatives. The Designated Representatives also utilized a scoring methodology to consider budget authorization recommendations to their Chief Executives. The criteria considered included:

- Importance (to the MCSF mission);
- Jurisdictional coverage;
- Likelihood of successful completion;
- Funding leverage (likelihood that success will lead to new funding sources);
- Urgency; and
- Linkage to MCES Communiqués and Committees.

Following the review, the Designated Representatives recommended to the Chief Executives a funding authorization level of \$357,000 for a range of activities in the categories of (1) Organizational Development, (2) Program Delivery, and (3) Regional Strategic Framework and Support to MCES meetings. To date, through the first six months of the MCSF inception award period, approximately 14 percent of the available funds have been expended or committed for immediate use.

There remain funds for authorization of additional activities by the Chief Executives for new or revised proposals that may be submitted to the MCSF Planning Committee of Designated Representatives. At the close of the 14th MCES, the Designated Representatives anticipate submissions of revised proposals for the Regional Invasive Species Council (RISC) training activity and support to traditional and non-traditional Women's organizations, conforming to the template format included as Attachment M to the Proceedings of the First Planning Committee Meeting of Designated Representatives (which can be downloaded from www.mcespalau.info ).

The SG also reports that funding support was provided to the Center for Micronesian Empowerment from the MCSF inception award for partial support to their Conference, "The Untapped Potential of the Marianas and Micronesian Workforce" held on October 20, 2010. A summary of the impressive work of CME in coordination with the Regional Workforce Development Council was also presented to the Chief Executives.

The MCSF inception award has also funded expanded assistance by the Graduate School acting on an interim basis to provide MCSF Secretariat support to Palau as the host jurisdiction for the 14th MCES and the associated committee work. The direct support provided included logo design, website development, and ongoing coordination with Palau's Summit Secretariat. During the MCES, assistance was provided in facilitation of the Second Planning Committee meeting of the Designated Representatives, Communiqué drafting, and initiating structured interviews with Committee chairs and selected members. As follow-up to the 14th MCES, the Graduate School will complete a Procedural Manual for MCSF support for MCES meetings to document the process and, presumably, to ease the

burden on future host jurisdictions. A report of the findings and recommendations from the structured interview process with the MCES Committees will also be produced and disseminated within six weeks after the 14th MCES. In anticipation of development of a multi-functional website for the MCES, committee documents and historical (archive) materials will be gathered in electronic form.

Looking forward, and with MCSF decision-making procedures and protocols now fully authorized, the Chief Executives have expressed their clear support to accelerate implementation of the inception award. The recommendation by the MCSF Designated Representatives to place a strong focus on fundraising to identify sustained sources of support for the Center, establish a physical location, and, identify an Executive Director for the Center was endorsed by the Chief Executives. The timeline of these activities should reflect the desire to allow the Graduate School to hand over the functional (Secretariat) support role it has been asked to provide on an interim basis.

The Chief Executives have also encouraged their Designated Representatives to consider further suggested reforms and enhancements of the MCES meeting format, committee structure, meeting timing and, perhaps a thematic focus, and other matters for consideration by the Chief Executives. Such recommendations shall be informed by the outcomes of the revised approach applied for the 14th MCES at the initiative of the host jurisdiction as well as by the report of recommendations coming out of the structured interviews undertaken with each of the MCES committees. The Designated Representatives are charged with making these recommendations in time to allow approval by the Chief Executives in advance of the 15th MCES.

#### Miscellaneous Issues

#### Water and Sanitation

The Chief Executives received a presentation on water and sanitation focused on Integrated Water Resources Management (IWRM) within the context of water security and sanitation. The Pacific Islands Applied Geoscience Commission (SOPAC) is currently executing the European Union (EU) funded Pacific IWRM National Planning Programme, which is designed to strengthen the governance structures and frameworks to mainstream Water Resource Management and Water Use Efficiency (WUE) into national planning processes of Pacific Island Countries. This project is complemented by the SOPAC executed, Global Environmental Facility (GEF) funded, project entitled "Implementing Sustainable Water Resources and Wastewater Management in Pacific Island Countries" (GEF Pacific IWRM Project).

Through the operation and planning of the GEF funded IWRM demonstration activities, national representatives from Palau, the Federated States of Micronesia, and the Marshall Islands identified and proposed a common process to facilitate the development of amendments or changes to existing water policies and coordination mechanisms in their respective countries. This process was considered in detail during the Micronesian Sub-Regional Water and Sanitation Policy Planning Workshop convened in Pohnpei, FSM, from November 8-11, 2010. A primary outcome of this workshop was the request to present the issues of water and sanitation at the 14th MCES.

The Chief Executives acknowledged the role of the Pacific IWRM Programme as a technical and advisory partner in the development of national water and sanitation policies and the revision of the Pacific Regional Action Plan on Sustainable Water Management, and supported the following recommendations:

- To establish a "Micronesian Water Committee" as a permanent working group of the MCES;
- In this effort, to form a start-up group to be chaired by the RMI comprised of the current IWRM Focal points and other cooperating partners as needed to draft the Terms of Reference and to report back to the next MCES;
- That each jurisdiction form National Water Task Forces for the development of national water policies and a regional water strategy, including national water outlooks and national investment plans for the water and sanitation sector by the 2012 MCES;
- That each jurisdiction conduct National Water Summits in 2011 in order to launch National water policies;
- That each jurisdiction participate in the review of the Pacific Regional Action Plan on Sustainable Water Management;
- That the Start-up Group/Micronesian Water Committee request SOPAC, SPC and other partners to provide technical and financial assistance for improved water and sanitation in Micronesian Island Countries; and
- In support of the UN resolution that Water and Sanitation is a human right, the establishment of a "Blue Ribbon Day" in support of a "Water for Life" awareness campaign and that this take place annually on World Water Day.

#### **Communication from SOPAC**

The Chief Executives received the statement provided by the Director of SOPAC which noted that as of January 1, 2011 SOPAC will become SOPAC, the Applied Geoscience and Technology Division of the SPC. The Chief Executives expressed their appreciation for the SOPAC Council's support for the recent Forum Leaders decision regarding the urgent need to:

- Sustainably increase the coverage of safe drinking water and basic sanitation services;
- Finalize the delineation of permanent maritime boundaries; and
- Expand the definition of disaster risk management beyond that posed by climate change to be people-focused, covering responses to health disasters as well as factoring in population growth and movement.

The Chief Executives agreed that the integration and mainstreaming of disaster risk management and climate change considerations (especially adaptation) into the national planning and budgetary processes was needed.

## **Region IX Federal Regional Council**

Governor Benigno Fitial reported on the meeting recently held in San Francisco by the Region IX Federal Regional Council (FRC) and attended by two of the MCES Chief Executives and other representatives of the region. The FRC is a consortium of 19 U.S. Federal departments and agencies with offices based in Region IX. Governor Fitial indicated that the joint meeting of the FRC and the MCES served to strengthen relationships and identify cross-agency issues and initiatives to be addressed in partnership by these entities. Governor Fitial also indicated that the meeting resulted in a Joint Statement of the Region IX Federal Regional Council and the Micronesian Chief Executives. In this Statement, the FRC and the MCES committed to working in partnership on technical assistance and other mechanisms, as appropriate, consistent with available resources and existing authorities, on a range of issues and initiatives.

The Chief Executives recognized and supported the Joint Statement and the potential partnerships, including:

- Grants Management and Transparency of Information;
- Climate Change and Renewable Energy
- Sustainable Communities Future;
- Workforce Development and Training;
- Improved Health and Education; and
- Improved Communication and Infrastructure.

The Chief Executives further agreed to support the Statement's commitment to coordinate, collaborate and work in partnership with the FRC, to achieve progress on these issues and initiatives.

## **Region IX Federal Regional Council**

The Chief Executives adopted a resolution expressing the heartfelt appreciation of the Chief Executives, on behalf of the people of the Micronesian region, for the contributions of Governor Felix P. Camacho in establishing and expanding the Micronesia Chief Executive Summit.

## **Conclusion**

The Fifteenth Summit of the Micronesian Chief Executives will be held in Pohnpei, FSM. The Chief Executives closed the 14th Summit and once again stressed the need to move forward on prior and new initiatives. There was also a recommitment by the Chief Executives to the implementation of these subregional initiatives endorsed since the start of the Micronesian Chief Executives' Summits. They agreed to greater coordination and communication to accomplish the goals set out since 2003. They also committed to fully integrating regional issues into ongoing governmental planning and budget processes within each jurisdiction.

President Toribiong thanked all the participants for their attendance and attention to these pressing issues before the Summit.

As you may be aware, the Micronesian Chief Executives' of the Pacific Islands recently requested your agency's expedited assistance to review our regional request to establish a Job Corps presence in Micronesia. In an earlier letter to Assistant Secretary Jane Oates, we explained the interest and developments of this request and the many collaborators supporting this workforce strategy.

The 14th Micronesian Chief Executives' Summit (MCES), guided by our many mutual networks, especially the expanding Pacific Workforce Investment Workgroup (PWIW) and the MCES Regional Workforce Development Council, support the need for a Job Corps training satellite center. This approach includes the Hawaii Job Corps Industry Council supporting the "Micronesia Works!" workforce system.

On behalf of the people of Micronesia, we continue to seek your review and approval of the establishment of a Guam Job Corps Satellite Center and invite your agency to continue to support the many related regional economies programs applicable to Micronesia.

#### 3A. Opening Remarks by Hon. Wesley Simina, Governor, Chuuk State

#### [Greetings]

On behalf of the People of Chuuk, and the government of Chuuk, and most especially the First Lady and I, I bring warm greetings from the people of Chuuk, and greetings for this holiday seasons. Merry Xmas and Happy New Year! I also take this opportunity to express our sincere appreciation and thanks to President Toribiong and his able staff, and the people of Palau, for such a wonderful welcoming and for such a wonderful hosting of the 14th MCES--today, and, I'm sure, in the next few days. Thank you very much for everything that you have prepared for us. I also would like to take this opportunity to express, on behalf of the people of Chuuk and the government of Chuuk, our sincere condolences and sympathies to the families and friends of the Senator who just passed away, as we just learned this morning.

I'm not going talk a great deal about important things. I just want you to know that my presence here, by myself, without any staff, is truly an indication of how much I have valued the works of the MCES.

You know, when the end of 1999 approached, there were all kinds of apocalyptic predictions, feelings, thoughts, as to what would happen when we ushered in the new millennium. These things did not happen on January 1st, or at midnight on December 31, 1999. And the world, all over, has realized that a lot of things--bad things, good things--happened during the first decade of this millennium.

And we in the Micronesian region were not spared the consequences, or the effects, of those things that have happened. Now the question for us as leaders of this region is this: What do we expect to achieve in the second decade of this millennium? I feel strongly that with this kind of unity, with this kind of common purpose, we really can accomplish all the things, in spite of all the events that will happen or transpire throughout of this world. So I feel that the closeness, the unity of our efforts, of our purposes, will certainly guide us in the next decade. So for that I would take this moment to at least address some of the focus of our MCES.

I have seen from the past few Summits that I have participated in, that just as we've seen the agenda of this 14th MCES, most of the things on this agenda are the same things that were on the agenda three or four years ago. So I feel that the issue now is not how much we value these issues, but how much we want to progress, to move forward, on these issues. And for that I would like to ask this conference, this Summit, to really take seriously the focus of our bi-annual meetings. I would like to ask that those experts, those of you who are very well-versed and wise in these kinds of matters, to lead us, to direct

us, guide us, on how we should make really good use of these two meetings—how we can advance and show progress on the issues that we are having.

I feel that two meetings a year for Chuuk, which is a poor state, we really struggle to come and join you in these meetings. So we would like to return as always from these meetings with a lot of concrete things that we can take back to our government, to our people, and show them that this region is truly moving forward with these regional and subregional issues that we are dealing with. So for that I just want to ask that we look at making our two meetings very focused on things that we should be doing.

Other than that, I have only two years left but I know Governor Camacho has less than a month. And I feel that some of us will miss this kind of conference and the good things that could happen as result of this kind of cooperation and unity that we've shown and demonstrated throughout our previous meetings, until today.

And I would like also to take this opportunity to say farewell to our colleague from Kosrae, Governor Weilbacher. I know you will no longer return to office and I wish both Governor Camacho and Governor Weilbacher all the best on your future plans and endeavors. And for the unopposed governor of Yap, I'm beginning to be very envious of your traditions and your way of doing things, because being unopposed in Chuuk is simply unthinkable. So for that I truly congratulate you, I laud you for your keen political maneuverings that made you become unopposed. And for some of us who are facing election in March, I need not speak, otherwise I will conflict myself. Sorry President Mori.

But indeed this kind of meeting we should always be guided by the very principles that these forerunners of our conference, especially Governor Camacho and your colleagues who started this conference, put in place. We truly thank you for all the foresight that you have put into this conference. It wouldn't be like this, if weren't those of you who started this, and had the foresight and commitment to move forward and expand to include some of us who have just joined. So thank you very much.

With that I would like to close. As we know this is a season of joy, because of only one thing, and that one thing is that we feel He has risen, that it's Christmas, the birth of our Lord. But if we look in the bible, I think it's 2nd Corinthians chapter 9 verse 15, it says; "Thanks be to God for this indescribable gift" and that what really gets me, because we think we know what it is--it's the birth of our Lord. But the bible describes it as that *indescribable gift*. We simply cannot fathom the love of Christ, and for that I hope we can share—share in thanking, share in giving, and share in joy. #### 3C. Opening Remarks by Hon. John Ehsa, Governor, Pohnpei State

#### [Greetings]

I feel very fortunate to be part of the development of the Republic in bringing the first computer in all of Micronesia, which was first developed here in Palau. That I must cherish. I am always thankful to the people of Palau because of things that have happened between our two places, the Republic of Palau and Pohnpei. First of all, I was here when you hosted the Micronesian Games, at which time, you also received one of our men who wanted to see the games but didn't ask to come on the plane. So three months before, he set out on his boat. I want to thank you for your hospitality in taking care of him. He's now back home very healthy and he extends his greetings to everybody here in Palau.

Also I want to thank the traditional leadership for their recently completed Micronesian Traditional Chiefs. I apologize for not being able to staff my Chiefs, Traditional Chiefs here, but I understand that they went away with much joy and fulfillment from all of what transpired here in Palau.

Coming back to the agenda, Mr. President or Mr. Chairman, I want to join the sentiments expressed by the Governor of Chuuk that we need to set some timelines. And I know it's going to be very difficult but at least it's something to look forward to. In light of the recently completed conference on Climate Change in Cancun, I wonder if some of us could brief us if there's any outcomes that would be applicable, which I expect that we may be appraised of in this conference because we don't meet that often.

At the same time thank you President Mori for deferring the Center for Sustainable Future to tomorrow, because I think there are issues we need to talk about, because I believe that this body, MCES, should have a secretariat. Because we need to keep the momentum moving and building, rather than taking a break after we meet and then we regroup when we meet again six months or one year down the road.

So with that, I just wanted to say a short comment and then again thank you Mr. President for the warm welcome I and my delegation received from the airport. I didn't have to worry about the stop signs, I was being driven. And I had a really nice liaison who is a graduate of COM Pohnpei, so I thought that was a strategy to keep me safe in Palau or keep me straight.

#### 3D. Opening Remarks by Hon. Sebastian Anefal, Governor, Yap State

#### [Greetings]

I think I brought to Palau the smallest delegation, with whom we bring greetings from Yap. We certainly would like to take this opportunity, Mr. President, to express our sincere appreciation to you being the host of the 14<sup>th</sup> Chief Executive Summit in Palau. Having been here for the last couple days, given the flight schedule between Yap and Palau, I certainly would like to share with you that we could not really tell the difference any longer between Yap and Palau, and the more we come to Palau the more we think we should spend more time in Palau.

The next couple days I'm sure we are going to tackle a somewhat extensive but very interesting agenda, and I see that there are a good many challenges laying before this group, many of which we have tackled before. Having gone to the Philippines for treatment a number of times, and coming to Palau, then finding it very necessary, given his health condition, to travel to Yap and to return to Palau.

Mr. President, we look forward to the rest of today and tomorrow for collaborative efforts on the agenda, but at this point in time I surely would like to, once again, thank all the organizers, all the sponsors, all the donors, and especially the young ladies and gentlemen who have performed the traditional dances for all of us this morning. If I may, let's give them a good round of applause.

# 3E. Opening Remarks by Hon. Benigo Fitiial, Governor, Commonwealth of the Northern Marianas Islands

#### [Greetings]

I'm just going to touch very briefly on the Federal Regional Council special meeting with the Micronesian Chief Executives that took place last month in San Francisco. But before I say that I would like to express again that it's always a pleasant visit each time I come to the beautiful Republic of Palau. And I want to extend my heartfelt appreciation to His Excellency Toribiong, for his superb undertaking to host this 14<sup>th</sup> Micronesian Chief Executive Summit especially on such short notice and on behalf of people of the commonwealth, my wife Josie, and my key staff behind me, I wish to convey our warmest greetings and best wishes to all our regional partners as well as this year's organizers, participants and guests.

Just last month, Governor Camacho and I along with representatives from each of Micronesia's island governments participated in unprecedented meeting with Region Nine, Federal Regional Council in San Francisco. For the very first time our Island Nations were afforded an opportunity to put a face to the many names we have only heard of or seen on communications related to funding, policy and technical assistance. For the members of the FRC, the feeling was very much the same. Not only did we become acquainted, but moreover, our government engaged in a meaningful dialogue that involved the everpressing challenges we continue to face this side of the Pacific. I will be discussing this historic meeting further as we move around in the agenda.

As we all know, our region continues to combat our fair share of challenges in today's competitive global economy. Our remoteness continues to raise barriers in the very areas that we seek growth and progress, economic development, climate change, renewable energy and adequate health care. As a region, we have all grown familiar with each other's efforts to seek higher standards for our communities. This is the embodiment of the Micronesian Chief Executives' Summit. It is our regional alliance to grow together as one Micronesia. As we begin this summit, we once again breathe new life into our commitment to collectively address our pressing issues that continue to inundate our respective communities. Together we stand vigilant and ever-ready to achieve our objectives. While it has been nearly six months since we convened in Saipan, I am excited to hear of the progress that has been achieved thus far by the committees that will be delivering presentations today, tomorrow, and the day after tomorrow. Although we have accomplished certain feats together, our region continues to face considerable challenges.

In the CNMI, we continue to move forward on our efforts to address the issue of energy. This still remains a major challenge for us. Just this past weekend, consumers saw an increase of 10 to 12 cents

per gallon of fuel. This is a significant increase and a tremendous impact given the dismal state of our struggling economy. Nonetheless, we continue to explore our options in the areas of alternative and renewable energy. Last week, the Commonwealth was visited by Assistant Secretary of Interior, Insular Affairs, Mr. Tony Babauta, and a team of experts from National Renewable Energy Lab (NREL). During their site visits, these experts conducted an assessment on the viability of different types of alternative energy solutions. Moreover, Assistant Secretary Babauta and I also announced the formation of the CNMI's Energy Steering Committee. This committee will take the lead in planning out the CNMI's efforts to transition our long-standing dependency on conventional energy to the more efficient options of alternative and renewable energy. While the process may seem tedious, we remain optimistic that there's a bright future ahead of us to secure reliable and innovative solutions to our energy challenges. It will take time, but I am confident that we will get there. We have already made a consider progress together and I look forward to continuing this partnership as we move ahead in our efforts to realize the growth and development of our region.

I am also looking forward to hearing from the Micronesia Center for Sustainable Future, and I would like to hear more about the Center's progress and plans from the planning meeting that was held a couple of months ago here in Palau. The Center will soon evolve into a key movement that will mold the strategic and developmental plans of our region. Through the support of the Center we have an opportunity to achieve greater efficiency in our approach to tackle the needs of our region.

We share only two common goals: recovery and prosperity. Our recovery is a process that will be heavily dependent on our cohesive ability to improve our infrastructure. Our prosperity will be an end result to our successes in reinvigorating our economic viability and becoming dynamic contenders in the world's ever-changing market trends. Through the partnerships we already have in place, we all can recover and we all can prosper.

#### 3F. Opening Remarks by Hon. Felix Camacho, Governor, Guam

Hafa Adai, and Good Morning to all! It is always a pleasure to be here in paradise. And, Mr. President, thank you for sharing your culture and the beauty of it with all the participants this morning is much appreciated.

This is my last gathering with the Micronesian Chiefs, and as I look back over the last seven years, we began in Palau and we end, at least for me, in this great and beautiful Republic. So Mr. President, Excellencies, fellow Governors, government leaders of The Republic of Palau, traditional leaders, Ibedul, members of the Ambassador Corps, Assistant Secretary Babauta, also our special guest from Hawaii, welcome, and to all participants.

It is truly remarkable that we are all here and as I reflect again over the last several years is remarkable as to how the different committees has evolved over time to address issues of great concern to the regions. We talked about the how it all began seven years ago, and the idea and the principles were founded on relationships and service, and how we as family in the Pacific Way can find ways to work together for the benefit of our people and our governments. And it all began initially as the Western MIcronesian Chief Executives Summit which was only inclusive of the territory of Guam, the Commonwealth of the Northern Marianas, the Republic of Palau and the State of Yap which is part of FSM. But over time, and I also want to thank Governor Benigno Fitiale and others who led to the inclusion of all of Micronesia. I believe even the American territory of Western Samoa Governor Tolafono is now interested on joining our group...so the Pacific family can be inclusive of not just what is considered the North Pacific but now also the South Pacific and perhaps all of Oceana. What started out as a concept based on family, based on tradition, based on services, is now evolving into truly a regional approach. I wish you all the best in the future as you continue your endeavors to find ways to help each other and succeed.

This being my last opening remark I beg of you your indulgence to allow me to extend a bit longer, as I want to share with you what I considered to be two paradigms of public servants in individuals. A person caan wake up in the morning and take the attitude of "it's me against the world." And if you begin your day like that, and you live your life as such, it is already adversarial and most confrontational. If you begin your day by saying that "you know, I'm a person that is born with certain gifts and talents, and I'm actually a gift to any organization and people that I'm involved with," you now begin your life and your day with the attitude of service. And I think that's what all the leaders are here for. We are public servants, elected at the highest of levels to help our people the best we can with the resources and abilities that we have.

There is saying that it's not the load that breaks you down, but rather the way you carry it. And I think the weight of leadership for all, of us considering the challenges of being remote islands with limited resources, is a heavy burden. But how we carry it makes the difference.

Earlier today a reference was made to the bible, in a Psalms and I just want point to one portion of Psalms 15 and it says "One must walk straight, act right and tell the truth. Don't hurt your friends, don't blame your neighbor and despise the despicable. Keep your word even when it cost you. Make an honest living, never take a bribe. You'll never be blacklisted if you live like this." And I think these are some of the principles we must live by.

So as I said that it's not the load that breaks you down but rather the way that you carry it. I wanted to share a short story with you that kind of embodies this, if you allow me. It's called "Finding Your Strength," and it relates to many of us leaders. And every single person that influences another is a leader, so all of you are leaders in your own right. And it begins like this,

There was a monarch, a king of long ago who had twin sons, and there was some confusion about which one was born first. Well as they grew to young manhood, the King sought a fair way to designate one of them as Crown Prince. All who knew the young men thought them equal in intelligence, in wit, personal charm, health and physical strength. Being a keenly observant King, he thought he detected a trait in one which was not shared by the other. Calling them to his Council Chamber one day he said, "My sons, the day will come when one of you must succeed me as King. The burdens of sovereignty and leadership are a very heavy burden. To find which one of you is better able to bear them cheerfully, I'm sending you together to a far corner of the Kingdom. One of my advisors there will place equal burdens on your shoulders. My crown will one day go to the one who first returns bearing his burdens as a King should. So, in a spirit of friendly competition, the brothers setup together. And soon they came upon and aged woman struggling under a burden that seem far too heavy from her fair body. So one of the boys suggested that they stop to help her; the other brother protested and said, 'We have a burden of our own to worry about. Let us be on our way.' The objector brother hurried on while the other stayed behind to give aid to the aged and old woman. Along the road, from day to day, he found others who also needed help. A blind man took him miles out of his way and a layman slowed him to his cripples walk. Eventually, he did reach his father's advisor, where he secured his own burden and started home with his safely on his shoulders. When he arrived at the palace, his brother, the objector, met him at the gate greeting his with dismay, then he said, 'I don't understand! I told our father the burden was too heavy to carry. How did you do it?' The future King replied thoughtfully, 'I supposed when I helped others carry their burden, I found this strength to carry my own.'

And so, all of us have had many burdens to carry, but it is in the service of others that we will find the strength to carry our own in our leadership.

I used that as a segue into what I had presented in San Francisco. I recognized the individual from the Office of Economic Adjustment, Department of Defense, that had been very instrumental in providing the Territory of Guam the funding and resources to understand the burden of this eventual military

build-up. As an island without the experience or capacity having dealt with such an endeavor, I realized that I could not navigate my way without proper advice and help. And my prayers were answered in the form of a man named Gary Kouravara. I properly honored him with an award called the "Ancient Order of the Chamorro". And that award is significant of others from offshore who have come to our island to help our people in a ways that we could not imagine. It's an honor bestowed by me, as governor, on others and signed by legislative speakers to designate and honor such an individual.

But today, I would like to also recognize two others that had come to my aid in my time as governor as consultants to try and navigate our way and understand the intricacies and complexities of a military build-up. And today, I'm honored to present the Ancient Order of the Chamorro to two individuals from Matrix Design Group, Celeste Werner and Mike Hrapla. Can you please come forward and receive the award.

And with that, I thank you very much.



# **3G.** Opening Remarks by His Excellency Emanuel Mori, President, Federated States of Micronesia

#### [Greetings]

I want to join the previous speakers in expressing our deep gratitude to President Toribiong and the people of Palau for the warm welcome and hospitality extended to us since our arrival at the airport last night. Like so many of our previous speakers, I always feel like I am home being in Palau. I have so many friends here with whom we share hardships at Xavier High School. So I have this ability with the young boys and now their distinguished officials of Palau. We went through hardships at Xavier High School but I'm very grateful that the rewards are very big. One of them is Dr Yano who is now a high official in the administration.

Governor Camacho, I want to thank you very much. You have contributed so much to the Summit and to the entire region. And because I am the current Secretary General, I want to focus on that. We have so many challenges and we need to talk about some kind of reforms on the way we conduct business during the Summit. For the Federated State of Micronesia we really cannot afford to meet four times a year. We bring a lot of people who participate in the various committees. So I would like to see some kind of change to the way we conduct business. Perhaps if I could suggests maybe twice a year, and also cutting down the number of committees that will be making presentations, until we can see some tangible progress. Those are just suggestions because we really need to make progress, tangible progress.

I, of course, thank Governor Fitial for hosting us last time and now President Toribiong. I thank you very much, but I think we need to see results of these meetings. So I hope during this meeting we will be able to discuss these difficult and challenging issues. That is the reason why I have requested that we defer

the agenda for today until tomorrow on the Micronesia Center for a Sustainable Future, and I thank you very much for agreeing that we defer it until tomorrow.

I don't want to talk too much because most of the important things have been said and I want to close by again thanking Governor Camacho for his contributions, active participation and hosting our many citizens in Guam. Governor Weilbacher is not here, but I also, on our behalf thank him because he's going out also as governor of Kosrae.

I need your prayers because I have an election in March. This could be my last meeting also, so I want to thank you very much for this opportunity.

She has sent letters of support to key leaders in the United States and US Congress. In the state of Hawaii, we have Senator Inouye and Akaka who have been most supportive of the cause and the best interest of the Palauan people. So I want to thank the United States. Guam and CNMI are members of the American political family. To her Excellency, Patricia Helen Reed-Rowe, the Micronesian States, the Freely Associated States of the FSM, the Marshall Islands and Palau, in my opinion are members of the American extended political family. And I thank Ben Fitial and Governor Camacho for attending the council in Region 9 in San Francisco and thank Secretary Babauta for his support. Secretary, I thank you for travelling thousands of miles, across many time zones, to come to Palau to show your support. We consider your presence as an indication of the United States' commitment to help our countries. Thank you very much.

I'd also like to express our profound gratitude to his Excellency Yoshiyuki Sadaoka, an ambassador from Japan to Republic of Palau, the very first full Ambassador to be appointed to reside in Palau. We share so much with Republic of the Philippines from labor force to education, to medical care. We thank the Philippines for being a close neighbor and a friend. Let's give the Philippines a round of applause.

We are so fortunate to have so many friends around the world to be friend our small nations. Our culture was shaped in fashioned, by our Island environment, by our interactions. Today we are blessed that we have so many generous friends from all over the world. I would like to give special recognition to the Ambassador to the Republic of Palau from the Republic of China. Please stand up and be recognized. Before I was elected President I was appointed the first Ambassador to the Republic of China, Taiwan. I learned so much from them and I would like to say that without their support, along with others, Palau, and most of us, would not be where we are today. And today I'd like to give special thanks to her Excellency, because when you choose Palau to be the venue for this conference instead of the State of Kosrae, we had to find funding for this conference. It would be remiss for me not to publicly acknowledge the special support from the Republic of China, in the form of \$50,000 grant to underwrite the cost of this conference. And for that we are most grateful, your Excellency.

I have heard wonderful words from all of you and to his Excellency President Zedkaia, I want to convey our condolences to you and to your family form the passing of your mother. And to the Governor of Guam, I wish you all the best as you exit from the heat of public life. And to his Excellency President Mori, I wish you all the best, and may the best man win, and you're the best.

#### **Summaries:**

The RWDC and PWIW delegates continue to nurture and support the regional economies strategies guided by the established Workforce Innovation Regional Economic Development (WIRED) principles and Strategic Doing!. *Micronesia Works...Shaping Regional Talent Development Systems* localizes good jobs for everyone as the signature framework for defining and guiding the RWDC workforce demand, supply. and training priority strategic areas. This approach continues to deliver and update the provisions of the RWDC 5-year strategic plan. The RWDC and the Pacific Workforce Investment Workgroup (PWIW) delegates held its technical meetings in Koror, Republic of Palau on December 13-14, 2010.

Presiding RWDC Chair, Josephine Ulengchong, convened the RWDC/PWIW meeting sessions with participating delegates (Federated States of Micronesia, Republic of Palau, and Republic of the Marshalls, Commonwealth of Northern Mariana Islands, and Guahan, Secretariat of the Pacific Community, and observers: Center for Micronesian Empowerment (CME). Area reports highlighted program updates and workforce investment/development strategic opportunities.

Detail discussions are provided in the RWDC/PWIW meeting sessions. In these discussions, promoting the RWDC regional workforce right jobs signature embraces the desired pacific regionalism charter and periodic alignment and updates to the plan. The recommended provisions represent the council updates that may be of interest to the Chief Executives and specific RWDC recommendations presented for endorsement.

The following recommendations include:

- 1. As it relates to the 13th MCES recommendations, the RWDC recommends that the MCES prepares a follow-up letter to the Secretary of the U.S. Department of Labor regarding the status of the MCES Regional Job Corps Initiative.
- The RWDC/PWIW continues to endorse the importance of extending the training opportunities
  for Procurement Technical Assistance Center (PTAC) to expand into the region. This includes
  leveraging the existing PTAC structures that exist in Guam, as well as including related
  programming support strategies i.e. Small Business Development Center through the Small
  Business Administration (SBA).
- 3. The RWDC's "STEAM" initiative provides for the positioning of the K-12 and post-secondary educational delivery systems to support Science, Technology, Engineering, Agriculture/Aquaculture and Math in response to the 21st Century talent development skill sets. The RWDC recommends MCES to continue reinforcing the STEAM initiative across all levels of the learning continuum.
- 4. The RWDC/PWIW recognizes self-employment as a workforce outcome, therefore promotes and endorses the ideals of entrepreneurship as defined in the 5-year strategic plan. The RWDC/PWIW continues to promote the regional branding of the Made-in-Micronesia strategy. The RWDC/PWIW recommends extending invitations to all regional Chamber of Commerce organizations to support the E-commerce regional initiative and to include active partnering of the Small Business Administration and U.S. Department of Agriculture programs and access to program resources.
- 5. As it relates to the Guam Military Buildup, the RWDC/PWIW recommends expanding the NDAA's area of solicitation to include specific recruitment strategies that allow U.S. citizens and Micronesian workers to be the order of priority in support of the MCES Micronesia Works interests.
- 6. The RWDC/PWIW recommends endorsing the resolutions provided by the collaborative entities (Center for Micronesian Empowerment and the Secretariat of the Pacific Community) specific to the provisions defined in the 5-year strategic plan goal areas and objectives. The RWDC/PWIW recognizes the positive contributions to the MCES RWDC Strategic plan and respects the sensitivities and collaborative interests of each area, while promoting the Micronesia Works! in the right way.





















#### 4C1. Micronesia Challenge Committee Report

Since the 13<sup>th</sup> Micronesian Chief Executive Summit, solid progress has been made on implementation of the Micronesia Challenge. The MC Steering Committee provided an update on the election of new officers with CNMI Focal Point Fran Castro as the new Chair, RMI Focal Point Yumi Crisostomo as the new Vice-chair, and Guam Focal Point Vangie Lujan as the new Secretary. Palau has confirmed that they will host the MC Regional Office and is currently identifying an appropriate space. The MC Committee also developed a draft 5-year Strategic Action Plan for the Steering Committee and Regional Office, articulating their vision, mission, and goals and objectives, and clarifying roles and responsibilities, to be finalized by the end of January 2011. The MC Committee has agreed on reducing the annual dues to \$10,000 per jurisdiction to be contributed at the beginning of each fiscal year. In addition, Charlene Mersai resigned as Regional Coordinator in October to pursue other interests and the Committee thanked her for hard work on the position for the past two years. The Regional Coordinator position terms of reference (TOR) are currently being refined and once finalized the position will be advertised.

The MC Committee also reported on conservation measures, fundraising and sustainable finance and communications. For conservation measures, the MC regional database coordinated by the Office of the Palau Automated Land and Resource Information System (PALARIS) is currently being piloted and a workshop on standardizing marine data collection and analysis with participants throughout Micronesia was held in Saipan, CNMI in November 2010, with support from NOAA. In terms of fundraising, Governor Fitial presented an "ask" for support for all jurisdictions in the Challenge at the last U.S. Coral Reef Task Force Meeting held in Gum, Saipan, and Pohnpei in September 2010 and NOAA is currently working to secure approximately \$1.5-2M annually in their budgets as a result of his request. Palau's Green Fee has brought in a total of nearly \$1.3 million since inception of the program in November 2009 and the Protected Areas Network Board is in the process of being chartered. In addition, the MC Regional Business Plan draft is currently under review by the MC Focal Points and appropriate agencies in each jurisdiction and will be finalized by the end of December. The plan will then be presented to the Chief Executives for review and endorsement. And finally, for communications, Guam and CNMI have initiated the MC Marketing, Outreach & Sustainable Support Plan, including the redesign of the website (www.micronesiachallenge.org), featuring interactive newsletters to be updated quarterly and a series with episodes focusing on different aspects of the MC. A Sponsorship Drive will be launched in January 2011. The Committee also provided an update on the MC Young Champions program which includes new interns for CNMI (2), Guam (1), RMI (1), FSM (1), and Palau (2). The Young Champions from Palau, Demei Yobech and Youri Ito, presented on their work with the Micronesian Shark Foundation to produce photo I.D. shark clips and a Shark Comic Activity Book, the tree and clam planting activities they coordinated as part of the Global Work Party with the 350 Organization, a global movement committed to the problem of climate change, and their new projects with the Palau International Coral Reef Center and Palau Conservation Society.

The MC Committee then briefed leaders on the next steps that need to be taken to continue to move the MC forward, including:

- Implementation of recommendations for sustainable financing identified in MC Regional Business Plan, at the jurisdictional level;
- Securing additional funding for regional terrestrial measures workshop (currently \$16,000 has been secured from The Nature Conservancy);
- Collaboration with other environmental initiatives (e.g., invasive species, solid waste, energy, MCSF, etc.)


Based on the recommendations of the MC Steering Committee, the Chief Executives directed the following actions to ensure that the Micronesia Challenge continues its momentum to provide significant benefits to the people of our region:

- Engaging in bi-lateral and multi-lateral high level discussions to leverage support for MC
- Continuing to promote the MC at regional and international levels to sustain interest in the initiative and help fundraising efforts for both the endowment and ongoing regional work, especially at the following meetings:
  - US Coral Reef Task Force Meeting in Washington, DC in February 2011
  - o Asia-Pacific Economic Cooperation summit in Hawaii in November 2011
  - 17<sup>th</sup> Conference of the Parties to the U.N. Framework Convention on Climate Change y (UNFCCC COP16) in South Africa in November –December 2011
- Continuing to support policies for on-the-ground conservation and mainstreaming of environmental efforts in development plans



#### 4D1. Regional Invasive Species Council (RISC) Committee Report

#### **Background**

The mission of the RISC is: "To reduce the likelihood of introduction of invasive alien species to islands across the region and to control or, when feasible, rid our islands of existing invasions through coordination of efforts throughout the Western Pacific." As noted in previous reports, cooperation through RISC has yielded significant progress in the advancement of invasive species awareness, prevention, and control in Micronesia; this regional cooperation is essential for both regional and local successes.

#### **Accomplishments Since the 13th Summit:**

The RISC met December 13<sup>th</sup> and 14<sup>th</sup>, 2010, to prepare for the 14<sup>th</sup> Micronesian Chief Executives' Summit (MCES). At this meeting, the Chair of the RISC rotated from the Kosrae to Pohnpei. The incoming Chair is Kadalino Lorens, iStop Chairman. RISC thanked Steven George for his excellent work and leadership of the RISC during the previous year. RISC also congratulated Bejay Obispo (Pohnpei) as the new Vice-Chair, and elected Diane Vice (Guam) as Secretary/Treasurer.

The RISC calendar for 2011, an important awareness-raising tool, will be completed in December and distributed in early 2011. The calendar was funded by the Secretariat of the Pacific Community (SPC), and coordinated by the RISC Secretary.

Letters from the Micronesia Chief Executives and RISC were sent requesting support from US National Invasive Species Council (NISC) for a full-time NISC-funded position within Micronesia to assist with coordination of invasive species efforts in Micronesia.

RISC members have supported the development of the Micronesia Biosecurity Plan (MBP) by providing local expertise to federal scientists who are completing the risk and pathway analysis reports that form the basis for the MBP. The scientific reports are due March 2011 and RISC will coordinate an informal review of these reports by local experts in each jurisdiction. RISC participation in the development process will help ensure that the final MBP will accurately portray priorities and needs within Micronesia for restricting introductions and spread of invasive species throughout Micronesia.

In order to plan for the eventual implementation of the MBP, a proposal to develop a Strategic Implementation Plan was submitted to DOD for funding. The Chief Executives can ensure the most benefit from this plan by instructing their invasive species coordinators and other appropriate staff to actively support the MBP and its implementation.

Individual member accomplishments are described in the attached member reports.

#### **Recommendations:**

We recommend that the members of the 14<sup>th</sup> Micronesian Chief Executives' Summit include the following in their communiqué:

- The Chief Executives reaffirm their commitment to provide a permanent and full-time Invasive Species Coordinator for each jurisdiction.
- The Chief Executives reaffirm their commitment to identify, in writing to the Chair of RISC, two representatives to RISC from each state and national jurisdiction.
- The Chief Executives reaffirm their commitment to send RISC representatives to two workshopstyle meetings per year, in addition to the Summits, to collaborate on invasive species issues and priority actions.
- The Chief Executives reaffirm their commitment to provide a minimum of \$2,500 from each jurisdiction to fund RISC's priority projects, as soon as the RISC bank account has been opened.
- The Chief Executives agree to continue to instruct their invasive species coordinators and other
  appropriate staff to participate actively in the development of the Micronesia Biosecurity Plan
  (MBP).
- The Chief Executives agree to sign a letter requesting SPC to fill the position of Plant Protection Specialist for Micronesia in 2011.
- The Chief Executives agree to sign letter of support to MCSF for funding strategic action plan and emergency response training for RISC members in April 2011.

Since the 13<sup>th</sup> MCES held in CNMI (June 2010) the Regional Energy Committee has moved forward with the directives set forth by the Chief Executives to which we are pleased to report on:

- Green Energy Micronesia (GEM) initiative
  - Recognizing that the GEM initiative remains our regional vision and platform in addressing mitigation to climate change, the REC is pleased to report the
  - 1. Continuous full support and advocacy that has been voiced and documented at the National, Regional and International arenas.
  - 2. Active on-the-ground EE & RE projects and research being implemented by all jurisdictions to meet the 20-30-20 Target.
- Information sharing; peer to peer exchanges regarding innovative mechanisms
  - 1. 1<sup>st</sup> Polynesia/Micronesia Regional Symposium on Energy Security held in Saipan (Oct.19-21, 2010) and hosted by the Energy Development in Island Nations (EDIN) partnership.
    - a. Where Palau was invited to present and share the success stories of the Energy Efficiency Subsidy Program and the Renewable Energy Financing Program which is a collaborative effort amongst the Palau Energy Office, Palau National Development Bank and Palau Public Utilities corp. to promote accessibility and deployment RE and EE technology through cost effective financing mechanisms.
  - 2. Center for Island Sustainability Conference to be held in 2011 "Launching the Guam MCSF Energy Policy Network.
  - 3. National initiatives to develop country specific energy sector websites for regional and international sharing and accessibility energy data, statistics and projects.
- Financial and Technical support to the energy sectors
  - 1. European Union EDF10 North REP funds and installation of country based energy specialists for each of the FAS countries.
  - U.S Government ARRA funds for RE and EE to each of the U.S. Territories.
  - Goal is to assess how each of these funds can be tapped to support or co-fund regional energy initiatives such as the Micronesia Energy Association (MEA).
- Framework for Action on Energy Security in the Pacific
  - Finalized and adopted by distinguished Energy Ministers and/or Energy Representatives of each Pacific Island Country and Territory (PICT) as members to the Secretariat to the Pacific Community (SPC).

- 2. Acknowledges the primacy of National Energy Policies and Plans as the principal means for achieving energy security in the Pacific.
- Micronesia Energy Association
  - 1. The Committee continues to be guided by the mandate placed upon us by previous MCES and the 10<sup>th</sup> MPS, noting the importance of strengthening energy coordination on a regional approach through the Micronesia Energy Association (MEA).
  - 2. We continue to remain in engaged consultation with SPC, as the Pacific Regional Leader on Energy Issues, to assist us, as agreed to by the Presidents at its 10<sup>th</sup> Micronesia Presidents Summit held in Koror, Palau, identifying the following key activities that will make up the appropriate model of the MEA:
    - a. Formulation of a 'Road Map'
    - b. Formulation of a Terms of Reference (ToR);
    - c. Assessment of the capacities needed in various jurisdictions including the MEA;
    - d. Assessment of all available and possible financing options and the defining of a sustainable financing plan;
    - e. Clearly defined partnership-framework with all relevant development partners and stakeholders of the energy sector in a coordinated whole-of-sector approach to energy issues at the regional level.
  - The Committee will appropriately report on the development of this work at the 15<sup>th</sup> MCES and 11<sup>th</sup> MPS as agreed to by our Leaders.

#### **Recommendation:**

The 14<sup>th</sup> MCES is requested to note the developments of the work presented and support the work of the Energy Committee in achieving the necessary tasks outlined above (a-e).



## **4F1.** Health Committee Report

The Regional Health Committee gave a status report on the crisis of non-communicable diseases in the region and on recent outcomes resulting from PIHOA Resolution 48-01, "Declaring a Regional State of Health Emergency due to the Epidemic of Non-Communicable Diseases in USAPI". This Resolution was passed by the Pacific Island Health Officers Association in May of 2010 and endorsed by the 13<sup>th</sup> MCES in Saipan, CNMI, in June 2010. Since that time, other key organizations have endorsed the resolution, including:

- The 10<sup>th</sup> Micronesian President's Summit
- The 5th Micronesian Traditional Leaders Conference
- The 51st meeting of the Association of Pacific Island Legislatures. APIL identified the NCD crisis as the theme for its next meeting.

The Regional Health Committee emphasized the importance of continuing to align international, regional and subregional bodies behind comparable resolutions, declarations and commitments that address the NCD crisis. Such harmonization will help leverage and coordinate resources and significantly strengthen mandates locally for more effective community-based efforts related to NCD prevention and control.

The Regional Health Committee reminded MCES participants that the world's fattest countries and territories are in the Pacific. Among Pacific entities, the USAPI rank the highest in obesity and some indicators for NCDs. For all MCES countries, NCDs are the leading causes of death, hospital admissions, off-island medical referrals, hemodialysis, disability, and loss of productivity. Rates of childhood obesity are on the rise in the USAPI, suggesting that the region faces a "tsunami" of NCDs in the future. If left unchecked, NCDs will significantly impede the economic and social development of MCES countries. Non-communicable diseases—including diabetes, hypertension, stroke, heart disease, and gout—are lifestyle-related diseases caused significantly by obesity, poor nutrition, tobacco use, alcohol abuse and lack of physical activity—all avoidable conditions with a coordinated, cross-sectoral approach to prevention.

The Health Committee emphasized the importance of executive leadership in:

- 1. Mobilizing resources through policy prioritization.
- 2. Changing the model of health care from the bio-medical disease model to a more integrated environmental approach (the wellness model)

- 3. Creating a better balance between the care and treatment of disease and the prevention of disease and promotion of health, including the balance of resources devoted to each.
- 4. Involving the "whole of society" by empowering people, communities and the workforce to pursue, possess and apply the knowledge of NCD prevention in all sectors.
- 5. Using NCDs to re-frame health systems priorities, such as strategic planning, human resources for health, laboratory strengthening, health data systems, quality assurance, and connectivity, and thereby provide greater focus and urgency to the development of sustainable and responsive health systems in the USAPI.

The Chief Executives supported the reported efforts of Committee and recommended the following:

- Continue strengthening the MCES agenda for non-communicable disease. To this end, explore strategies for encouraging NCD-related priorities and priorities among all sectors, including health, trade, education, and finance and for integrating NCDs into the overall strategic priorities of the MCES Secretariat, the Micronesian Center for a Sustainable Future.
- Continue to increase knowledge and awareness of the NCD crisis in the USAPI, among
  international, regional and subregional bodies, such as the Pacific Ministers Meeting, the
  Regional Committee Meeting of the WHO Western Pacific Regional Organization, the General
  Assemblies of the United Nations and the World Health Organization, and other world, regional
  and subregional organizations in health, trade, education, finance, and other sectors.
- Support the development of a cross-sectoral economic analysis of the current and projected impact of NCDs in the USAPI and request technical assistance agencies, such the World Health Organization, to assist the USAPI with undertaking such an analysis.
- Strengthen MCES advocacy for US Medicaid eligibility for citizens of the Freely-Associated States residing in US States and Territories, as an important step in NCD prevention and control for these individuals. To this end, invite the newly-elected Governor of the State of Hawaii, The Honorable Neil Abercrombie, to the 15<sup>th</sup> MCES to discuss and coordinate strategies for achieving Medicaid eligibility for Compact Migrants. Governor Abercrombie, during his tenure in the US Congress, has been among the most outspoken advocates for such a measure. The lack of Medicaid insurance eligibility for FAS citizens in CNMI and Guam results in significant delays in care: Many of these individuals forego preventive and curative treatment, including pharmaceuticals, until their condition worsens and they need expensive emergency care.

## 4G1. Transportation Committee Report

#### **Transportation**

#### **Aviation**

The Transportation Subcommittee discussed on the issue for consideration by the Chief Executives in all aspect of security services of both airport and seaport to meet the minimum IMO and ICAO requirements and still meet challenges imposed by U S Transportation Security Administration and U S Coast Guard respectively.

Pursuit of federal funds and extension of eligibility to the Freely Associated State by US Government is critical. The Committee also reported that collaborative efforts regarding air service and shipping route development would be beneficial to expansion of services for all Micronesia islands.

Two types of Airport Improvement Funding. Entitlement Fund and Discretionary fund. The Entitlement funding levels are proportionate distribution based on the numbers of enplanements for the airport and Discretionary funds are distributed on the competitive basis on airport performance. The AIP Reauthorization Bill is required. The proposal to extend the eligibility of Micronesia airports' for AIP grants are being reviewed with the proposal to extend Micronesia airports' eligibility to 2012.

Airport Improvement Program (AIP) in Republic of Palau (on going)

- 1. Extension of Apron to accommodate four Boeing 767 RON at Palau International Airport adjacent Runway 9
- 2. Palau International Airport Master Plan including Airport Certification Manual and feasibility study for Peleliu and Angaur Airstrip

#### Marine Transportation Issues

- 1. Increased number of Military Ship visits due to military build-up in Guam.
  - With the Military Build-up in Guam, Palau is expected to receive increased number of
    military ship visits. Military Sealift Command has unofficially expressed interest in
    increasing their ships' visits to once a month, provided Palau could install additional Aids to
    Navigation outside of the Malakal Passages to ensure the ship can depart at
    moment's notice.
- 2. "White List" Recertification under the "Manila Amendments" to the International Convention on standards. Training and Certification of Watchkeeping.

- New changes to the STCW Convention were approved in Manila in June of this year. These
  will come into force in 2012. The new changes will require countries that are parties to the
  Convention to make submissions for the "White List". This will allow licenses issued by the
  countries to be accepted internationally.
- 3. Printing of Nautical Charts for the Small Island Pacific States by Defense Mapping Agency.
  - There is a report from shipping lines that the Defense Mapping Agency for US Department
    of the Navy no longer prints nautical charts for the small islands, including Palau. If this is
    so, the FAS need to make a request to the US Department of the Navy for DMA to continue
    this service as it is critical to maritime safety of the FAS and the FAS have no capacity to
    print the charts themselves.
- 4. Training of Marine Pilots in the MCES States
  - The MCES States need to explore work opportunities for its citizens as Deck Officers on ships
    that serve the MCES States under Micronesian Shipping Commission's License. This will
    provide necessary sea experience required for MCES States citizens to be qualified for
    higher level of licenses leading to marine pilot qualifications.



## 4G2. Transportation Committee Presentation

#### 14th MCES

#### MCES Committee on Transportation Marine Transportation Issues

 Upgrades of Aids to Navigation to support Increased number of Military Ship visits due to military build-up in Guam.

With the Military Build-up in Guam, the Region is expected to receive increased number of military ship visits. Military Scalift Command has expressed interest in increasing their ship visits to once a month, provided that additional Aids to Navigation be installed to ensure safety of navigation.

Therefore, the MCES Committee on Transportation recommends that:

- MCES requests assistance from US Department of Interior for grants to upgrade existing Aids to Navigation to enhance safety of marine navigation.
- MCES requests US Coast Guard to consider the needs of the MCES States when phasing out its ATON maintenance equipment and/or ATON.

"Meeting the Challenges of the "Manila Amendments" to the International Convention on standards. Training and Certification of Watchkeeping (STCW).

With the new changes to the STCW Convention that were approved in Manila in June of this year, which will come into force in January 2012, the MCES States must undertake additional upgrade training and institutional changes to meet the new STCW requirements.

Therefore, the MCES Committee on Transportation recommends that:

- MCES adopt a Resolution to request the Economic Development Division of the SPC to seek funding for upgrades of MCES seafarers in the Region to ensure they meet the new requirements of the STCW "Manila Amendments".
- MCES adopt a Resolution to request SPC EDD to work with the Pacific Regional Maritime Association to make necessary changes to STCW Courses to ensure continued compliance of the maritime institutions in the Region.
- MCES adopt a Resolution to request SPC EDD to assist MCES countries to meet the new requirements of the STCW "Manila Amendments".

#### 3. Training of Marine Pilots in the MCES States.

Development of new Marine Pilots in the MCES States continuous to be an important issue to ensure safety of navigation and protection of the pristine environment enjoyed by the Region.

Therefore, the MCES Committee on Transportation recommends that:

- MCES explore means of securing funding for the training of new pilots.
- MCES Transportation Committee be tasked to explore opportunities for new and existing pilots to undertake training in other MCES ports and to report back to the Summit.

#### 4. Addressing High Cost of Goods in the Region.

The cost of shipping on containers being transshipped through Guam continues to remain high which is raising prices of goods in the MCES States. This causes difficult burden on the citizens of the MCES States in times of economic hardships.

Therefore, the MCES Committee on Transportation recommends that:

 MCES dialogue with the Government of Guam and the Guam Port Authority to see if the cost of transshipment of containers bound for the other MCES States be reduced or eliminated.

- In 1978, the first 12 World Heritage sites were inscribed. They included Yellowstone National Park and the Galapagos Islands.
- If a site is threatened, UNESCO helps create a plan—and often provides funding—to ensure the site's preservation. There are currently 30 sites on the List of World Heritage in Danger.





#### A. Emerging Regional Projects

- 1. PIRRIC Information Portal Update Funding needed to update portal and upload all waste management related documents for the region.
- 2. Center for Island Sustainability Conference The University of Guam will be hosting the CIS Conference in 2011. PIRRIC will be presenting a paper titled "The Emergence of Cooperative Environmental Governance in Micronesia".
- 3. Pacific Islands Regional Recycling workshop Guam has been participating in preliminary discussions with USEPA officials on hosting a recycling workshop in Guam during 2011 that could serve as a capacity building opportunity for Micronesia. Guam has requested for PIRRIC to participate in the discussions with USEPA to ensure maximum coverage of the region's interests and needs.
- 4. Pacific Islands Environment Conference (PIEC) Palau reported that it will be hosting the PIEC in September 2011 and in partnership with USEPA, Region IX.
- 5. Rio +20 Technical Working Group It is anticipated that there will be preparatory meetings and island specific forums leading up to Rio + 20. PIRRIC believes that this is an opportunity to demonstrate our regional cooperation in addressing common cross-cutting issues regarding solid waste management and other related issues.





#### 4J1. Communications Committee Report

Your Excellencies and Honorable Governors of the 14<sup>th</sup> Micronesian Chief Executive Summit, thank you for this opportunity to report to you all on the progress of your Committee on Communications.

First of all, let me tell you that the Committee on Communication met yesterday which consisted of the following members: The Honorable Jackson Ngiraingas, Minister of Public Infrastructure, Industries and Commerce of Republic of Palau; The Honorable Francis Itimai, Minister of Transportation, Communication & Infrastructure of Federated States of Micronesia (FSM); Mr. Richard L. Misech, General Manager of Palau National Communication Corporation (PNCC); Mr. Takkon Chin, Chief of Division of Communications under MPIIC

As you all know, communication plays a vital role in all sectors in the social and economic development in our Micronesian region. Additionally, communication plays an equally important role that aids other sectoral developments within our islands.

There is no question that Guam and the Commonwealth of the Northern Marianas Islands have seen greater advancement in the ICT sector to which the other MCES members have aspired to achieve; however, your committee on communications has also come to realize the vast differences of the ICT structures between the member countries of the MCES.

These differences have thus contributed to the overwhelming discussions in the communication committee, of which specific issues directly affecting Freely Associated States have been identified with little relevance to Guam and the Northern Marianas Islands.

Therefore, understanding the need to engage Guam and Saipan on communication issues that promote commercial developments as well as the assistance of ICT to other key sectors such as health and education;

And given that the issues mainly discussed within the communication committee for the MCES remain solely those of the Freely Associated States;

It is our recommendation, still since the last Summit, that such communication issues specific to the Freely Associated States shall be better addressed and resolved at the Micronesian President's Summit;

Your Committee feels that the issue of communication dealing with FAS states being discussed in the MCES should be elevated to the consideration of MPS. For instance, the Communication Committee is still focus on the work with SPC for the development of National ICT Framework of FAS only.

The Committee as a whole will continue to participate and provide a supportive role to other committees and the overall MCES, assuring that cross cutting communication issues relevant amongst all members can still be readily reported and addressed.

Thank you for the opportunity and your committee remains readily available to elaborate further on all relevant communications issues and address any further concerns you may have.



# 4K1. Micronesia Center for a Sustainable Future (MCSF) Committee Report

#### **Background**

The Second Planning Committee Meeting of the Micronesian Center for a Sustainable Future (MCSF) Designated Representatives was held on Tuesday, December 14, 2010, in advance of the 14<sup>th</sup> Micronesian Chief Executives Summit (MCES) in Palau. The Designated Representatives from the Commonwealth of the Northern Marianas (CNMI), Federated States of Micronesia (FSM), the Republic of Palau, Yap State, and Kosrae State were in attendance.

The MCSF Planning Committee adopted an agenda that included:

- (1) Preparation of the presentation materials for the 14<sup>th</sup> MCES plenary session, including:
  - a. clear delineation of the issues that require the consideration of the Chief Executives to affirm their approvals with respect to outcomes of the 1<sup>st</sup> Planning Meeting of the MCSF Designated Representatives that was hosted by Palau on October 5-6, 2010;
     and
  - b. review of next steps to be proposed to the Chief Executives.
- (2) Discussion of possible reforms or enhancements of the MCES meeting structure, committee structure, and other matters, including:
  - a. discussion of the Secretariat (MCES support) function of MCSF;
  - b. review of the proposed completion of structured interviews with Committee chairs and lead members to identify opportunities for the MCSF to add value and support the outcomes targeted by the MCES Committees; and
  - c. review of the need to prioritize fundraising, especially to identify core funding to enable the hiring of an Executive Director and formal establishment of the Center so that the interim support role the Graduate School is providing under the MCSF inception award can be effectively transitioned by June 2011 if possible.
- (3) Review of the MCSF inception award budget, including:
  - a. review of funds expended to date;
  - b. budget authorizations as currently recommended for reaffirmation of approvals by the Chief Executives; and

c. consideration of new initiatives or revised proposals for budgetary authority.

#### **Meeting Outcomes**

During item one of the agenda and in a subsequent meeting with the proposed panel members for the MCES plenary presentation, the Committee developed the presentation (Attachment 1). It was agreed that the panel members would include the Designated Representatives of the host jurisdiction, of the Secretary General (FSM) and of the CNMI. A significant objective of the presentation is to get an informed and deliberative reaffirmation of the approval by the Chief Executives of the items presented in the decision paper that was produced after the first Planning Committee meeting (Attachment 2).

Item two of the agenda involved discussion of the actions taken to-date by the Graduate School, under the MCSF inception award, to provide (Secretariat) support functionality on an interim basis until the Center has its own Executive Director (and staff). The Graduate School has provided support to Palau in their preparations for the 14<sup>th</sup> MCES. In addition to facilitating a Planning Committee teleconference one month in advance of the meeting, there has been direct support to Palau's Summit Secretariat including logo design, website development, and ongoing coordination with Palau's Summit Secretariat. During the MCES, the Graduate School will assist in facilitation of the Second Planning Committee meeting, support the Communiqué drafting process, and initiate structured interviews with Committee chairs and selected members to identify opportunities for the MCSF to add value and support the outcomes targeted by the MCES Committees. In the follow-up to the 14<sup>th</sup> MCES, the Graduate School will complete a Procedural Manual for MCSF support for MCES meetings to document the process and, presumably, ease the burden on future host jurisdictions. A report of the findings and recommendations from the structured interview process with the MCES Committees will also be produced and disseminated within six weeks after the 14<sup>th</sup> MCES. In anticipation of development of a multi-functional website for the MCES, Committee documents and historical (archive) materials will be gathered in electronic form.

Discussion under item two of the agenda also involved a presentation by the Designated Representative for Palau reporting the ways in which the host jurisdiction's Summit Secretariat had collaborated with and benefited from the support of the Graduate School under the MCSF inception award. Minister Yano also described the reforms or enhancements that Palau had, on its own initiative, introduced for the 14<sup>th</sup> MCES. Most importantly, the host jurisdiction modified the time allocated for Committee presentations, requested that the Committees complete substantial portions of their deliberations prior to the meeting (by virtual means) and to complete their Committee reports, if at all possible, by the end of Monday of the MCES week. The intent of the tightened timeframe is to enable the committee members from each jurisdiction to brief their principals on progress and recommendations to be presented to the Chief Executives prior to the start of the formal MCES plenary sessions.

Further discussion under item two of the agenda was dedicated to the need to prioritize fundraising under the MCSF inception award and to plan for the transition from the Graduate School's interim support role to the emergence of a fully functional and staffed MCSF. It was agreed that the urgency of this matter should also be raised to the attention of the Chief Executives to seek their input and ideas to

secure sources of sustained funding for both the core functions of the Center (as Secretariat to the MCES) and programmatic outreach in support of MCES Committee priorities.

With respect to item three of the agenda, the budget status was reported by the Graduate School to the Designated Representatives. The current version of the MCSF Inception Award Budget Tracking Sheet for Designated Representatives (Attachment 3) was reviewed and the Designated Representatives were able to ask clarifying questions about the expenditures to-date and about the relatively large proportion of the budgetary resources which remain unexpended. Clear direction was given to expedite expenditures and programmatic activities once full endorsement of the procedures and protocols is reaffirmed by the Chief Executives during the 14<sup>th</sup> MCES. This same Tracking Sheet had been distributed by e-mail with a decision memo to all Designated Representatives on November 24, 2010, and was approved (with no objections) as of the effective date of December 2, 2010. A summary of the budget status was incorporated in the presentation to be delivered to the Chief Executives.

The Designated Representatives discussed the procedures for considering new or revised proposals for budget authorization and they determined that the MCSF Planning Committee as a whole could receive proposals from Committees or third parties; and, alternatively, Designated Representatives themselves could endorse proposals for consideration by the Planning Committee. It was noted the consideration by the Planning Committee would follow the existing procedures, including a polling of Designated Representatives for scoring/ranking, a poll to recommend a specific level of budget authorization, followed by each Designated Representative presenting to their respective Chief Executives to determine if there would be no objections (over a ten day period).

Based on preliminary discussions among the Designated Representatives it is understood that the Committee will receive revised proposals for the Regional Invasive Species Council (RISC) training activity and support to traditional and non-traditional Women's organizations. The proposals should utilize the template format that was included as Attachment M to the Proceedings of the First Planning Committee Meeting of Designated Representatives (see Attachment 4 to this Committee Report).

The Designated Representatives were also briefed by representatives of the Center for Micronesian Empowerment (CME) on their mission and program activities. CME received funding support (expenditure totaling \$10,500) from the MCSF inception award for partial support to their Conference, "The Untapped Potential of the Marianas and Micronesian Workforce" held on October 20, 2010.

#### **Conclusion**

The Second Planning Committee Meeting of Designated Representatives concluded that there should be an "exit meeting" immediately following the successful conclusion of the 14<sup>th</sup> MCES while all of the Designated Representatives (in attendance) are still in Palau. This meeting will focus on lessons learned, next steps, and addressing certain outstanding issues that have been brought to the attention of the Designated Representatives that may affect the effective continued implementation of the MCSF inception award by the Graduate School. This meeting will commence immediately following the closure of the 14<sup>th</sup> MCES on Thursday December 16, 2010.





#### Consideration of Including the Issue of Water and Sanitation in Micronesian Countries as an Agenda Item for the Micronesian Chief Executive Summit


The Pacific Islands Applied Geoscience Commission (SOPAC) is currently executing the European Union (EU) funded Pacific Integrated Water Resources Management (IWRM) National Planning Programme. The Programme is designed to support 14 Pacific Island Countries to strengthen their governance structures and frameworks to mainstream Integrated Water Resource Management (IWRM) and Water Use Efficiency (WUE) into national planning processes. This project is complemented by the SOPAC executed, Global Environmental Facility (GEF) funded project entitled "Implementing Sustainable Water Resources and Wastewater Management in Pacific Island Countries" (GEF Pacific IWRM Project).

Through the operation and planning of the GEF funded IWRM demonstration activities, national representatives from the Republic of Palau (Palau), the Federated States of Micronesia (FSM), and the Republic of the Marshall Islands (RMI) identified and proposed a common process to facilitate the development of any required amendments or changes to existing water policies and coordination mechanisms in their respective countries. This process was considered in detail during the Micronesian Sub-Regional Water and Sanitation Policy Planning Workshop convened in Pohnpei, Federated States of Micronesia from 8th-12th November 2010.

It was subsequently agreed that a sub-regional approach following the process depicted in Figure 1 would be trialed in the three abovementioned countries. Key milestones in the process included the conduct of National Water Summits on World Water Day 2011 (22 March) and the preparation of National Water Status Reports and Framework Water and Sanitation Policies. It was suggested by the national water focal points present at the abovementioned meeting that effort should also be made to include the issue of water security and sanitation in Micronesian countries on the agenda of the upcoming Micronesian Chief Executive Summit (MCES) to be convened in Palau during December 2010. The specific objectives and outcomes that the group hoped to achieve by including water and sanitation on the agenda of the December 2010 MCES meeting were identified as:

- 1. To present the Pacific Integrated Water Resources Management Programme to National Chief Executives, and outline initiatives in the Micronesian region for national water policy development and national water resource management demonstration projects;
- 2. To seek support of National Chief Executives to form a "Micronesian Water Committee" as a permanent working group of the MCES;
- 3. To seek support from National Chief Executives for the conduct of National Water Summits in 2011 and to review the Pacific Regional Action Plan on Sustainable Water Management;
- 4. To seek support from National Chief Executives for the development of national water policies and a regional water strategy, including national investment plans for the water and sanitation sector by the 2012 MCES; and to
- 5. To have the role of the Pacific IWRM Programme acknowledged by Chief Executives as a technical and advisory partner in the development of national water and sanitation policies and the revision of the Pacific Regional Action Plan on Sustainable Water Management.

Thank you Mr. Chairman. I have been given three minutes to deliver a ten minutes speech. So I will ask for all the indulgence of the usual introductory remarks.

My fellow chief executives, here we are again at the conclusion of a very successful and fruitful Summit. We have spent a past couple of days tackling current issues besetting our respective island governments as well as enjoying the warm hospitality and the Alii spirit of the wonderful people of Palau. It's certainly another remarkable and memorable experience.

Over the course of the past two days we received updated progress report and future plans from each of the respective committees. With the presentation that we have listened to and information we have absorbed, we are now equipped with the refined projection of where we stand as island communities, more importantly, where we stand, as a region.

To state the obvious, we know our absolute challenges and our impending obstacles. Perhaps we can even say we know the threats of economic hardship too well. We know all of this because we each live this uphill battle every single day. However, it is up to us as leaders to make the changes our people long for.

Thank you, my brother, for your insights and your commitment to give life to what was then the Western Micronesian Chief Executives Summit to what has evolved into the present day Micronesian Chief Executive Summit. Aside from pioneering the formation of the summit, Governor Camacho has done a remarkable job for his beloved island of Guam, over the course of his eight years in Guam. In the CNMI as well, governor Camacho has warm the hearts and respect of our community. During our terms together us governors, our communities witness the very much improved and harmonious working relationship between the two Marianas jurisdictions. afforded the opportunity to establish a National Guard unit under the umbrella of the Guam Army National Guard. I would also like to thank the overall committee and various committees for putting together a very successful event. To my fellow chief executives and your delegations that have travelled here, I wish you all a safe journey as you return home. May you all have a blessed Christmas and a very happy new year.

I will be entertaining all of you later tonight. Thank you.

#### 5C. Honorable John Ehsa, Governor, Pohnpei State

On behalf of my delegation I would like to thank his Excellency president Toribiong, the traditional leaders of Palau and the people of Palau for hosting the 14th conference. We are enjoying every minute of our stay and we are grateful for the customary warm reception and gracious hospitality of the people of Palau.

Your Excellencies, colleagues, honorable governors, distinguished guests, ladies and gentlemen...

By all accounts this conference has been a resounding success. I have been informed that all the committee meetings, the presentations and the discussions, dances and singings that had been taking place within the walls of this magnificent center, as well as the dance floors and the karaokes of Koror over the past two days have been up to speed and have lived up to our expectations. This has indeed symbolized another important step forward in our collective endeavor and quest for improving the economic condition of our region, safeguarding the environmental integrity of our Islands, the health of our people, and safeguarding our traditions for the prosperity of future generations of Micronesia. I believe we all should be proud of this unity of purpose that we have.

It is often difficult for me indeed to give a statement after eloquent speeches by governor Fitial have been made, and knowing that others will follow after me. In Pohnpei we say it's like walking in the foot prints of a carabau, as my friend Thomas Pablo said during the meeting in Guam after I left for medical reasons. Nevertheless, I am proud to be here at this moment in our history and as a Governor of the state of Pohnpei.

It is even harder after two days of detailed dialogue and discussions covering wide range of subjects concern and interest of our region. Almost everything important that needed to be discuss regarding economic development, climate change, environment conservation, transportation and communication, health and even the cost of doing business has been discussed. But most difficult, knowing that this will be the last MCES to which we will have our friend the honorable Felix Camacho join us as Governor of Guam. Governor, you have always been the source of inspiration to this conference. Your leadership in always trying to bring our Micronesian region together, and your strong commitment to our Islands' growth and the development of the people of Micronesia will surely be missed. However, I remain confident that the indelible path you have engraved in the MCES in the spirit of reaching out to your fellow islanders, to address our Micronesians issues, will continue to guide this conference into the future. You have truly inspired me and I am sure, all of us in this room will miss you. As I think of it now and I only wish, that at my last MCES, I can leave behind the sense of hope that you will be living behind as we close this meeting. Please keep yourself available so that we can seek your leadership and guidance as we continue this forum into the future.

For all of us I believe that the most important thing now is to take action on what we have concluded. I will not talk at length, I would like to mention just a few things for the sake of emphasis before we walk out of this room and into the dance floors and karaokes tonight. The issues I would like to raise will be general points on the agenda items in the interest of time.

- I am delighted that with the successful of the 14th conference, the transportation committee continue to look at ways to improved our shipping issues and other aviation needs. To the committee, I challenged you to explore the possibility of creating a counterpart to the Micronesia shipping commission that focuses on aviation, perhaps a Micronesian Aviation Commission, and provide a concept at the next MCES. I recall in your presentation that you are working in collaboration with the SPC, first I ask that this endeavor you also involve SPC.
- To the health committee, your presentation was very compelling. The numbers you provided representing the health of our people is very striking. I will take your recommendations back to Pohnpei and work with my health and education departments to ensure that Pohnpeians join the other MCES members and establish rigorous action plans to help us improve how we deal with all the diseases, but most specially those that you have mentioned including diabetes, obesity and nutrition and food security. Currently in my stay at Pohnpei my administration is implementing a school lunch program which we believe help deal with our health issues. It includes menu consisting of local food that I've been deprived of our diet of important food stuff. We recognize that food security is broader than just the availability of the food or increased crop production. Food security also means regular access to quality food that provides the full complement of necessary nutrients for a healthy and productive life. It is also closely linked to economic security, environment security and human security. I hope that successive conferences go beyond information or experience sharing to agreed and concrete actions to be taken on this important issue which, to me, needs immediate action.
- I understand that during the conference there was a report at the previous conference. This is a good thing, however if we are to succeed we have to go beyond the readouts of previous proceedings. We need to follow up discussions and follow up actions on the decisions on our previous meetings. For this reason, I proposed that each MCES jurisdiction entertain budget items from the respective members of the committees, into your annual budget, to ensure that they are equipped to continue the work after and before each MCES.
- To the Micronesia challenged and the young champions, environmental conservation, climate change invasive species, regional waste management groups, I applaud your efforts to link the issues of environment and climate change into sustainable development.
- Energy, education, food security, health and other sectors, I welcome the discussion that you are having about these connections and how we treat them comprehensively. The more linkages we can make among this top priorities, the more effective our development programs will be. I welcome your creative ideas about how to further our integration together. Why I feel this is important is because of the need for us to remember the great work of conservation champions. Their contributions to our environmental conservation and sustainable development aspirations will continue to guide the way we pursue these issues into the future. I recall two issues that you raised in your presentations to which I think can be advanced in the

communiqué. One, I believe, is in regard to an interest in hosting a US Fish and Wildlife office in either CNMI or Guam to serve our region that would support our conservation efforst, including the Micronesian Challenge. In this regard I urge the MCES to send a letter of endorsement to our friend and very good supporter Mr. Babauta, at the Interior Department. The other issues really go to the heart of what we are doing in Pohnpei. Your presentation highlighted interconnections of environment and economic development issues. Specifically, the critical issue of climate change and sustainability in relation to effective management of natural areas and prevention of invasive species. These issues are the focus of many UN conventions that give our islands the opportunity to ensure our perspective on these critical issues is understood.

Our desire to effectively address such issues is the reason we have created the Micronesian Center for Sustainable Future, an advancement of the Micronesian Challenge. In light of the critical nature of these issues to our region and the need for continued international attention and dialogue to address them, I suggest we invite a representative from the appropriate UN agencies to the next meeting, to discussed further international efforts and allow the UN to have a better understanding of the risks our region has our many efforts to address them. In this regard, I urged the invasive species group or committee to prepare an invitation to the appropriate human agency for the MCES to consider.

Finally, I must say that like all of you I am proud to be a Micronesian, living in this time of our history. We have in our hands the opportunity to define a future of our islands that is of our own, and not one that is dictated to us. I continue to believe that because we are a peaceful region, we contribute to the global security of our planet by setting examples for the other regions as we work together to promote economic growth, sustainable development, good governance and security, and continue to strengthen our regional cooperation and integration in the areas where the region can gain most through sharing our resources and alignment of policies.

With that piece, I thank you for listening and I think we are all ready to go fishing tomorrow. Thank you all.



# 5D. Mr. Steven George, Director of Resources & Development, Kosrae State
