I'd like to especially call your attention to Attachment A of the Proceedings, the "Decision Paper for Chief Executives."

As decided at our meeting and outlined in the Decision Paper, it is requested that each of you, as the nine Designated Representatives, seek the approval of your respective principals for the recommended process and procedures contained in the Paper. These processes and procedures will remain in place for the MCSF during the period of the inception award and as implemented by the Graduate School. Approval will be presumed granted in the absence of an objection from any of the nine jurisdictions, and in the absence of any request for further time for consideration of approval beyond a period of ten days from electronic delivery of the Paper on October 15, 2010.

In addition, tomorrow I will forward a notice to proceed with support to the Center for Micronesian Empowerment (CME) conference in Guam, October 20th. This activity was highly scored during our planning meeting, and requires urgent action given the close proximity of the conference date. Per our agreed-upon protocols, the CME notice will be on a five-day, no-objections basis from Designated Representatives.
